Eligibility - Student visa applications

To be eligible for a student visa application fee waiver from the Australian Government, you must have held a student visa on or after 1 February 2020 and have been unable to complete your program in your original visa validity because of the impacts of COVID-19.

This includes students who:

- deferred study as they were unable to enter Australia because of travel restrictions
- were forced to reduce to a part-time study load
- were unable to complete their work-based training or placements

This measure is **not intended for students who are applying for a new student visa because of ordinary reason** (including if you have failed a program or a unit of study, deferred for personal reasons or voluntarily reduced your study load.)

Eligibility – 485 visa applications

Only study undertaken outside Australia whilst holding a student visa will count towards the Temporary Graduate visa study requirements.
